FILATI BE.MI.VA. SPA is obliged to inform that this product contains AMNI SOUL ECO®, the Polyamide fiber with enhanced biodegradability that decomposes in around 5 years for products disposed of in landfills. **FILATI BE.MI.VA. SPA** is also responsible to advise about Amni SOUL ECO® Branding Procedure to brands, distributors or final sellers, and guide them about the technical requirement for brand certification, which are secured by RHODIA and the tests performed through *ASTM D5511 – Standard Test Method for Determining Anaerobic Biodegradation of Plastics Materials Under High-Solid*. The use of Amni SOUL ECO® trademark is authorized only for the products and the claims aforementioned.

FILATI BE.MI.VA. SPA is strictly prohibited from providing any label which contains Amni SOUL ECO® trademark to its customers in order to be used in garments. The Brand will obtain the final trademark license agreement after submitting its garments to Amni SOUL ECO® Branding Procedure. Thus, the use of Amni SOUL ECO® trademark can only be authorized, in written, by Rhodia. It is forbidden, under any circumstances, the total or partial assignment to any third party producer of the approval as well as the use of the trademark Amni SOUL ECO®, now granted by RHODIA to the company.

This term does not exempt licensed company herein and its customers, of the obligation of obtaining the register with local regulatory and sanitary agencies in accordance to the legislation of each country.

RHODIA is authorized to promote your brand and your products on RHODIA's websites, for a period equal to the term of this agreement. This Agreement is effective for two years from the date mentioned in the heading of this document and may be renewed by the parties by mutual agreement in writing.

Any breach of the conditions set forth herein shall lead to the immediate interruption of this Agreement and will be considered as the illegal use of the trade mark, giving rise to the penalties provided in Law 9279/1996 and will oblige the breaching party to pay to RHODIA an indemnification for the damages and losses caused to Rhodia.
